And there was plenty for all

We all know that guy. He's part of the reason for who we elected in 2016. I keep being reminded of him when I talk about helping those that need a hand. He's the guy who thinks he never needs a hand so no one else should get one either. We make policies to appease him and still we fail. I want a world that will make policies to please Barbara.

Barbara wasn't a client. I didn't have "clients" then. It was about 40 years ago and I had been blessed to be asked to handle, as a volunteer, community outreach activities for St. Timothy UMC in northwest Detroit. It was nearing Christmas and I was in charge of helping those in need in the neighborhood. Barbara was in Inkster. Some didn't think that was the neighborhood, but when you are called you answer.

Barbara was a wisp of a woman, barely 5 feet tall with no front teeth and thinning hair. She would have easily passed for mid-60's in age. She was about 30. She had two young school aged boys in her subsidized housing apartment. She had been nearly beaten to death several times by a huge man who terrorized her for years. She had fled. He was arrested and now in prison for a long time. Her greatest Christmas gift was her life. Her freedom. She needed nothing more. She asked for nothing more. She was a referral.

When we spoke she was thankful to get "any" help for the boys. She had nothing to give them. I don't remember what was wrapped and delivered to them. They were two young boys. A couple of cars, maybe an "action" figure, a Nerf football, a pack of no-brand UNO cards, some dollar store gloves, and some coloring books and crayons would have been pretty typical. I remember only one item in the food basket. It probably had some packs of oat meal, hot cocoa (with the little marshmallows), potatoes, a can of vegetables, some oranges and (the one thing I remember), a 12 once fully cooked square ham. It was enough ham for I meal for the 3 and maybe a little for a small sandwich the next day.

Barbara didn't have a car and when I delivered the gifts on Christmas Eve day I remember thinking I wish we had done more. She and the boys had endured so much, had asked for nothing and were getting little more than that. There was nothing left to give. The food was all gone, the toys were depleted, the wrapping paper used up. I had, as I would so many times in the future, in many ways, opted for thinner stew to feed more as opposed to simply saying "no." Still, it felt like this family deserved more. When she opened the door, you would have thought a J.L. Hudson's truck had pulled up. Barbara was happy and excited and very thankful. I left thinking I really knew we should have done more.

A day or two after Christmas, Barbara called me. She thanked me again and said that she and the boys had a wonderful Christmas, the best in years. 40 years later her story doesn't still stay with me because of any of the above. It was what was next. After all she and they had gone through she had a right to have her a day to herself. But, she didn't do that. She said her boys had two friends next door and they had no toys or gifts. So, the boys invited them over and "shared their gifts." And, Barbara invited their mom over and they all had dinner. Barbara described a feast that somehow came from a bag with enough for 3 people. And, "the ham, Mr. Ted, the ham was wonderful, and there was plenty of it for all of us, and I even had enough to make myself a sandwich later." It was amazing and genuine.

I know "that guy" is out there that I keep hearing about complaining. It is his right. So far it is still a free world. I would like us to remember in that same world there are people like Barbara who even when they are down and out find the room to say, "there's enough for everyone."
